## Cancellation of candidature against CEN RRC 01/2019

Document Verification for PwBD and non-PwBD candidates against CEN RRC-01/2019 was held from 24.02.2023 to 16.03.2023 & 24.03.2023 (1<sup>st</sup> round of DV), from 11.03.2024 to 15.03.2024 & 19.03.2024 (2<sup>nd</sup> round of DV), from 29.07.2024 to 06.08.2024 & 21.08.2024, 22.08.2024 (3<sup>rd</sup> round of DV), from 23.09.2024 to 27.09.2024 & 17.10.2024 (4<sup>th</sup> round of DV), on 22.10.2024, 04.11.2024 & 12.11.2024 (5<sup>th</sup> & 6<sup>th</sup> round of DV) and on 22.11.2024 & 28.11.2024 (7<sup>th</sup> round of DV).
