Candidates are hereby instructed to bring along their call letters {CBT,PET(as applicable for Non-PWD candidates except CCAA),DV} against CEN RRC 01/2019. They are also instructed to bring Original documents as instructed in the notification of CEN RRC 01/2019 and other relevant documents as per DV instructions upload on RRC ER website. The original documents along with self-attested photocopies of documents and 10 photographs (which were used during CBT application) are to be brought along.

If any such enlisted candidates fail to attend on their schedule date or does not bring their documents as per instructions, **he/she will not be given any further opportunity and his/her candidature of Level 1 post would be treated as cancelled.**

The candidature is liable to be cancelled, at any stage of recruitment or thereafter, in case of inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of the candidates coming to the notice of RRC/ER at any stage of the recruitment process.

Candidates may please note that merely being called for medical Examination does not confer any right for appointment to the notified posts.

- (B) (i) Sri Rakesh Mishra (Registration No. 1141145899) and (ii) Sri Reddi Ganesh (Registration No. 1141022054), panel papers were returned back from Howrah Division with the remarks of FPE “insufficient prints and inconvenient to verification” at Divisional Level in respect to their documents through earlier for re-verification at Division level. Both of them have been cleared by ex-GEQD and panel papers are being sent to Howrah Division for further pre-recruitment formalities.
