

RECRUITMENT AGAINST CULTURAL QUOTA FOR THE YEAR 2022-23

1. On the basis of results of the written examination for recruitment against Cultural Quota for the year 2022-23 held by RRC-ER on 15/04/2023 at CPO Office, First Floor, Eastern Railway Headquarters, Fairlie Place, Kolkata, the candidates with the Application numbers, as given below, have qualified for the Stage-II of the recruitment process i.e. Assessment of Talent in the Applied Discipline.

2. Candidature of these candidates is purely provisional subject to their being found eligible in all respects. The candidates will be required to produce the original certificates in support of their claims pertaining to age, educational qualifications including cultural qualification (**Degree/Diploma/Certificate in respective discipline only from Govt. recognised University/Institute**), community, and other claims by the candidates. They are therefore required to keep the said documents ready with them.

3. The certificates of the candidates are valid only if they are issued from Govt. recognised university or institute (as per Railway rules). The onus to provide such proof rests with the candidates only.

4. If it is found at any stage of the recruitment that the candidate does not fulfil all/any of the conditions of eligibility, his/her candidature will be cancelled without any notice and no appeal against such cancellation will be entertained.

5. The Stage II of the recruitment process is to be held on 08.06.2023 tentatively at 11.00am at Fairlie Place, Eastern Railway Headquarters, 17 N.S. Road, Kolkata – 700001. The candidates must note that there will be no separate call letter for the said assessment and this notice may be treated as the call for the said examination. The candidate must bring the retained portion of the e-call letter of the written examination on the specified date at the specified venue and time.

6. The candidate with the following Application numbers are advised to visit the website of RRC-ER i.e. www.rrcer.com kolkata at least once every day for latest updates regarding the recruitment process and all other details. Further, candidates are also advised to refer to the detailed notification for the recruitment against cultural quota dated published on RRC-ER website.

7. No request, whatsoever, shall be entertained in any circumstances for change of date for the stage II of the recruitment process.

8. Marks obtained by all candidates shall be uploaded on the website of RRC-ER within one month of the declaration of the final results i.e. after all the stages are completed and results are declared.

Although utmost care has been taken to upload and publish the result correctly, RRC-ER reserves the right to rectify any inadvertent error or typographical mistake at any stage or cancel the candidature of any candidate at any stage if any discrepancies are found in application details, documents etc.
