## NOTICE FOR DISPUTED CASES REGARDING CASTE

Kolkata, date: 17.04.2024.

(A) It has been noticed that there are many candidates in RRC CEN-01/2019 who have claimed to be of Scheduled Tribe (ST) community from the state of Bihar and Jharkhand with sub caste which is not in par with the enlisted sub caste of Central List as approved by Ministry of Tribal Welfare, Government of India, **specially from Lohar community**. Many of such candidates are shortlisted for Physical Efficiency Test (PET) by RRB-Kolkata as ST as per their claim in the online application. Many of such candidates on various occasions claimed to be ST on submission of Annexure-I and subsequently claimed to be OBC on submission of Annexure-II.

The list of Scheduled Tribe (ST) as in Central List is as follows:-

- (B) As per Office Memorandum No.F.No.11030/36/2018-C&LM dated 23.10.2019 issued by Ministry of Tribal Affairs, on date LOHARA and LOHRA is in ST list of Bihar and LOHAR is not in ST list of Bihar.
- (C) LOHAR community is placed at Sl.No.18 as **Kamar (Lohar, Karmkar, Visvakarma)** in **Other Backward Community (OBC)** Central List of Bihar issued by National Commission of Backward Classes.
- (D) Further to above, it is mentioned that judgement dated **21.02.2022** of Hon'ble Supreme Court of India in Writ Petion (Civil) No. 1052/2021 in Sunil Kumar Rai & Ors. Vs The State of Bohar & Ors., directive of Hon'ble Supreme Court is as follows:-
  - "31. Resultantly, we allow the writ petition. We quash the impugned Notification. We may notice that in the impugned Notification, the direction is to give certificate to 'Lohara', ('Lohar') community. While 'Lohara' is a member of the Scheduled Tribe, 'Lohar' is not. Therefore, while we have quashed the notification, it must not be understood as meaning that 'Lohara' which is already included in the category of Scheduled Tribe is to be affected by this Judgment. We clarify that the quashing of the impugned Notification will be qua 'Lohar' community and the Lohara will continue to get the benefit vouchsafed for them under the Presidential Order as amended by the Acts. We direct that the respondent No. 1 shall pay costs in the sum of Rs.5,00,000/- (Rupees Five Lakhs) which shall be done within a period of one month from today and the respondent shall produce proof of the payment of the costs by production of the receipt of the same within a period of six weeks from today. As regards the cases against the petitioners, it is for the petitioners to work out the remedies in the appropriate Forum and necessarily, the Courts will take note of the pronouncement which we have made today.

We would expect that the first and the second respondents will issue appropriate direction(s) to the authorities in the light of today's pronouncement.

Pending application(s), if any stand disposed of."

- (E) A final opportunity of re-checking of documents will be extended to the candidates as attached in Annexure-A with date and reporting time. Enlisted candidates are advised to be in complete readiness in view of submission of current certificate from competent authority issued after 21.02.2022 in light of order of Hon'ble Supreme Court of India in Writ Petion (Civil) No. 1052/2021 in Sunil Kumar Rai & Ors. Vs The State of Bihar & Ors. Certificate should be at par to instructions at the bottom of Annexure-I as well as Annexure-II, as **applicable**. The list of competent authority for issuing the caste certificate in format are "1. District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner / Deputy Collector / 1st Class Stipendiary Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner. 2. Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate. 3. Revenue Officers not below the rank of Tehsildar. 4. Sub Divisional Officer of the area where the candidate and / or his / her family normally reside(s). 5. Certificates issued by Gazetted Officers of the Central or of a State Government Countersigned by the District Magistrate concerned. 6. Administrator/ Secretary to Administrator (Laccadive, Minicoy and Admindivi Islands)". It is reiterated that the certificate as well as Annexure to be submitted should have been issued AFTER 21.02.2022 (Date of order of Supreme Court in Writ Petition).
- (F) Candidates enlisted in Annexure-I should report to the office of Railway Recruitment Cell, Eastern Railway, 56, C.R. Avenue, Kolkata 700012 on **their scheduled date and time and if any candidate fails to report and/or fails to submit documents** at par with the conditions mentioned above, his/her **candidature will stand cancelled** and **NO further appeal/prayer** will be entertained by RRC-ER. Calling for re-checking of documents does not confer any right to candidate against RRC CEN 01/2019.
- (G) Candidates are advised to keep checking the website of RRC-ER regularly for further information/updates.
- (H) The candidature is liable to be cancelled, at any stage of recruitment or thereafter, in case of inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of the candidates coming to the notice of RRC/ER at any stage of the recruitment process.
- (I) While every care has been taken in preparing the list of the candidates for further process, RRC/ER/Kolkata reserves the right to rectify any inadvertent error or typographic / printing mistakes. RRC/ER regrets inability to entertain any correspondence from candidates who have not been shortlisted
