IMPORTANT NOTICE FOR CANDIDATES

Notification No. ER/CBT/01/2024(RUNNING) dated 22/05/2024

Regarding re-medical examination of the unfit candidates for the post of Assistant Loco Pilot (ALP) in Level-02 against 50% quota held on 19.09.2024 against Notification No. ER/CBT/01/2024(RUNNING) dated 22/05/2024.

1. The Computer Based Test (CBT) for the post of ALP in Level-02 against 50% quota against Notification No. ER/CBT/01/2024(RUNNING) dated 22/05/2024 was conducted by RRC-ER on **19.09.2024 (Thursday)** from 11:00 hrs. to 13:00 hrs.
2. Based on the performance in the Computer Based Test (CBT) conducted on 19.09.2024 by RRC-ER for the said post, the list of candidates who have secured the minimum passing marks for the said CBT i.e. **60%** of the full marks with no relaxation for SC/ST (para 4.6 of notification no. ER/CBT/01/2024(RUNNING) dated 22/05/2024), has already been published on the website of RRC-ER (www.rrcer.org) vide notice no. RRC/ER/ALP/Departmental Quota/2024(333) dated 28/10/2024.
3. Medical examination of the candidates who has secured the minimum passing marks for the said CBT has been carried out in respective units.
4. As per the reports received from the units, the list of candidates who were found unfit in A-1 category is enclosed with this notice as **Annexure – A**.
5. This is to inform that, in terms of IRMM, CHAPTER 5, PARA 522, candidates who were found unfit in A-1 category can submit application for re-medical examination within 07 days of notice i.e. on or before **13/12/2024 to their respective units**, addressing to Sr. DPO/WPO/Dy. CPO(W) of your unit with a copy to RRC-ER.
6. Candidate should note that, in their written application for re-medical, candidates must clearly mention their name, employee no., CBT Roll no. and name of their unit (division/workshop). The candidates should send e-mail on rrcerkolkata2022@gmail.com enclosing the copy of their application for re-medical on or before **13/12/2024**.
7. If any candidate in **Annexure – A**, fails to submit written application for re-medical within 13/12/2024 on their respective unit (division/workshop), he/she will not be given any further opportunity and his/her candidature for the said post would be treated as cancelled.
8. The candidature of the candidates in **Annexure – A** are purely provisional, arranged randomly and not in the order of merit.
9. While every care has been taken in preparing the list of the candidates, RRC-ER reserves the right to rectify any inadvertent error or typographic /printing mistakes.
