**Notice for the Re-check of Documents against CEN RRC-01/2019**

Above mentioned candidates are hereby advised to be present at the office of RRC/Eastern Railway, 1<sup>st</sup> Floor, RITES Building, 56, Chittaranjan Avenue, Kolkata-700012 (near Central Metro Railway Station) on their reporting date (mentioned above) at 10.00 hrs. for further process and be in readiness to stay in Kolkata area for further 2 to 3 days (except Sl. No. 1,2, 5, 9, 17, 29, 30, 31, 32 & 45) at their own arrangement for Medical, if required.

Sl.no.1 & 2 have already been sent for medical examination after DV but due to disputes on their PwBD certificates, they were returned back without completion of their medical examination. Sl. No.(5, 9, 17, 29, 30, 31, 32 & 45 ) have already done their medical examination.

They are hereby instructed to bring along their call letters for DV, PET (except PWBD & CCAA candidates) and CBT which was earlier uploaded on the website of RRC ER i.e. [www.rrcer.org](http://www.rrcer.org). They are also instructed to bring Original documents as instructed in the CEN RRC 01/2019 and other relevant documents as per DV instructions uploaded on RRC ER website. **The original**

**documents along with self-attested photocopies of documents and 10 photographs (which were used during CBT application) are to be brought along.**

Documents to be brought by candidates in original (as applicable) as per Notification of CEN RRC 01/2019 in accordance with Clause No. 18.4 (Sl. No. 01 to 21) are reiterated below:

1. Matriculation/High School Examination Certificate or Equivalent certificate as Proof for Date of Birth and Matriculation Qualification. (The candidate's name and the father's/mother's name mentioned in the application will also be verified with reference to the names mentioned in this certificate.)
2. NCVT(NTC/NAC) / SCVT Certificate as applicable.
3. SC/ST certificate in the format as per **Annexure I**.
4. OBC-NCL certificate as per **Annexure II** (Not older than one year from the date of document verification)
5. Non creamy layer declaration by OBC-NCL candidates as per **Annexure II A**
6. Income and Asset Certificate to be produced by Economically Weaker Sections as per **Annexure III**.
7. Income Certificate for Waiving Examination Fee for Economically Backward Classes as per **Annexure III A**.
8. Minority Community declarations on Non-judicial Stamp Paper as per **Annexure IV**.
9. Original discharge certificate for Ex-servicemen.
10. Medical Certificate for Persons with Benchmark Disabilities (PwBD) as per Format at **Annexure V(A)/ Annexure V(B)/ Annexure V(C)** as applicable.
11. Self-declaration for Ex-servicemen as per **Annexure VII**.
12. NOC from serving employees with date of appointment from current employer.
13. NOC from Serving Defense Personnel (ExSM) with probable date of discharge.
14. Gazette notification and/or any Legal document in case of formal change of name as mentioned in Para 1.7
15. Receipt of offline payment if made through a challan at SBI branch or Pay-in-slip at computerized Post Office.
16. Self-Certification by the Transgender candidates
17. J & K domicile certificate, if applicable.
18. Certificate of eligibility issued by the Government of India, as per para 4.1(f).
19. Decree of divorce/judicial separation from the competent court of law as applicable and Affidavit stating that the candidate has not remarried.
20. Death Certificate of husband in case of widow and Affidavit stating that the candidate has not remarried.
21. Ex SM candidates who secure civil employment after applying for this CEN should give self-declaration to the concerned employer about the details of application against this CEN as soon as they join. The acknowledged copy of this declaration along with NOC from the civil employer should be produced during document verification.

If any such enlisted candidates fail to attend on their schedule date or does not submit documents as per instructions, **he/she will not be given any further opportunity and his/her candidature of Level 1 post against CEN RRC-01/2019 would be treated as cancelled. All the above candidates may treat this as LAST AND FINAL CALL FOR RE-CHECK OF DOCUMENTS.**

The candidature is liable to be cancelled, at any stage of recruitment or thereafter, in case of inconsistency /deficiency in the data furnished by them in their online application or any malpractice on the part of the candidates coming to the notice of RRC/ER at any stage of the recruitment process.

Candidates may please note that merely being called for checking of documents does not confer any right for appointment to the notified posts.
