**NOTICE REGARDING RE-CHECK  
OF PENDING BIO-METRIC CASES-CEN RRC 01/2019**

The Document Verification (DV) of candidates against CEN RRC 01/2019 was held from 24.02.2023 to 16.03.2023. The candidates, whose Biometric did not match on their scheduled DV date and did not turn up for Biometric Matches at RRC from 08.08.23 to 11.08.23 are hereby advised to be present at the office of RRC/Eastern Railway, RITES Building, 56, Chittaranjan Avenue, 1<sup>st</sup> floor, Kolkata 700012 (near Central Metro Railway Station) on 16.01.2024 for further process and be in readiness to stay in Kolkata area for further 2 to 3 days (at their own cost and arrangement) for Medical, if required List of such 8 candidates are appended below. The reporting time for the candidates will be from 10.00 hrs.

They are hereby instructed to bring along their lower part of call letter for DV which was earlier uploaded on the website of RRC ER i.e. [www.rrcer.org](http://www.rrcer.org). They are also instructed to bring Original documents as instructed in the CEN RRC 01/2019 and other relevant documents as per DV instructions upload on RR CER website. The original documents along with self-attested photocopies of documents and 08 photographs (which were used during CBT application) are to be brought along.

Documents to be brought by candidates in original (as applicable) as per Notification of CEN RRC 01/2019 in accordance with Clause No. 18.4 (Sl. No. 01 to 21) for document verification is reiterated below:

1. Matriculation/High School Examination Certificate or Equivalent certificate as Proof for Date of Birth and Matriculation Qualification. (The candidate's name and the father's/mother's name mentioned in the application will also be verified with reference to the names mentioned in this certificate.)
2. NCVT (NTC/NAC) / SCVT Certificate as applicable.
3. SC/ST certificate in the format as per Annexure I.
4. OBC-NCL certificate as per Annexure II (Not older than one year from the date of document verification).
5. Non creamy layer declaration by OBC-NCL candidates as per Annexure II A.
6. Income and Asset Certificate to be produced by Economically Weaker Sections as per Annexure III.
7. Income Certificate for Waiving Examination Fee for Economically Backward Classes as per Annexure III A.
8. Minority Community declarations on Non-judicial Stamp Paper as per Annexure IV.
9. Original discharge certificate for Ex-servicemen.
10. Medical Certificate for Persons with Benchmark Disabilities (PwBD) as per Format at Annexure V(A)/ Annexure V(B)/ Annexure V(C) as applicable.
11. Self-declaration for Ex-servicemen as per Annexure VII.
12. NOC from serving employees with date of appointment from current employer.
13. NOC from Serving Defense Personnel (ExSM) with probable date of discharge.
14. Gazette notification and/or any Legal document in case of formal change of name as mentioned in Para 1.7.
15. Receipt of offline payment if made through a challan at SBI branch or Pay-in-slip at computerized Post Office.
16. Self-Certification by the Transgender candidates.

17. J & K domicile certificate, if applicable.
18. Certificate of eligibility issued by the Government of India, as per para 4.1(f).
19. Decree of divorce/judicial separation from the competent court of law as applicable and Affidavit stating that the candidate has not remarried.
20. Death Certificate of husband in case of widow and Affidavit stating that the candidate has not remarried.
21. Ex SM candidates who secure civil employment after applying for this CEN should give self-declaration to the concerned employer about the details of application against this CEN as soon as they join. The acknowledged copy of this declaration along with NOC from the civil employer should be produced during document verification.

If any such enlisted candidates as appended below fail to attend on their schedule date or does not submit documents as per instructions, **he/she will not be given any further opportunity, as this is their LAST and FINAL opportunity and his/her candidature of Level 1 post would be treated as cancelled.**

The candidature is liable to be cancelled, at any stage of recruitment or thereafter, in case of inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of the candidates coming to the notice of RRC/ER at any stage of the recruitment process.

Candidates are hereby informed that Biometric/Photo/Signature match is mandatory for further process. If any candidate does not clear biometric / photo / signature match, in spite of being checked on their schedule date, these cases would further be referred to finger print and Ex-GEQD expert. After receiving the final report of experts, in the case of such impression, the final decision taken by RRC/ER would be final.

Candidates may please note that merely being called for re-check Biometric does not confer any right for appointment to the notified posts.

While every care has been taken in preparing the list of the candidates for further process, RRC/ER/Kolkata reserves the right to rectify any inadvertent error or typographic /printing mistakes. RRC/ER regrets inability to entertain any correspondence from candidates who have not been shortlisted.
