PROVISIONAL PART PANEL AGAINST RRC CEN-01/2019 FOR
RECRUITMENT IN LEVEL-1 POSTS AS PER 7TH CPC

- A. Against 10,868 notified vacancies against Centralised Employment Notice No. 01/2019 on Eastern Railway, Metro and CLW- Provisional part panel of 52 candidates for recruitment in posts in Level-1 of 7th Central Pay Commission (CPC) Pay Matrix is appended herewith. Candidates may please note that this provisional part panel only consists of candidates whose candidature was kept pending due to lacunae in documents and have now submitted the same. Result of other DV shortlisted candidates will be uploaded in due course. This panel is purely provisional and does not confer any right to any candidate for job in Railways. The place of the candidates is subject to further verification check at Unit level from where the individual offer of appointment would be issued.
- B. The allotment of posts for candidates is as per merit, medical status and availability of vacancy as per option provided by the candidates in their online application, subject to fulfillment of all eligibility criteria mentioned in the notification as well as on clearance of biometric matching. Allotment of division/unit will be done by concerned zonal unit/production unit. Final appointment will only be post verification of all relevant certificates and documents such as caste certificate, educational certificates etc.
- C. The decision of RRC-ER in the matter shall be final. This is only a Provisional part Panel and NOT THE FINAL PANEL which does not confer upon the candidates any right for appointment in Railway Service. RRC will not entertain any individual queries in this regard.
- D. The list of candidates who were called for DV and subsequent medical examination, but their names have not appeared in panel, would be uploaded separately along with the reason of non- inclusion of their names or revised status of such candidates in panel.
- E. Certain candidates' result is kept pending and will be declared in due course, along with the reason for inclusion or non inclusion.
- F. While due care has been taken in preparing the part panel, RRC-Eastern Railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage. If any discrepancy or malpractice is noticed or brought to the notice of RRC at any stage, RRC-ER reserves the right to rectify any inadvertent error or typographical/Printing mistakes and declare any candidate unsuccessful or delete the name of candidate from the notified panel.
