Re-check of the Documents against CEN RRC 01/2019

It is hereby informed that after the completion of the 1st round of Document Verification (DV), all posts corresponding to medical standards B2 and C1 were exhausted. Accordingly, during the 2nd to 7th rounds of DV, all non-PwBD candidates who cleared the DV were referred for medical examination under medical standards A2 to B1 only.

Upon receipt of the medical fitness/unfitness certificates, only candidates declared medically fit under standards A2 to B1 were considered and already been empanelment against CEN RRC 01/2019.

A total of 79 candidates were declared medically unfit for A2 to B1 standards. As there were no available posts under B2 and C1 at that time, their candidature was cancelled.

Subsequently, following the initial empanelment process, a few vacancies under A2 to B1 medical standards have arisen due to the resignation or demise of some candidates within one year of joining. In view of this, the Competent Authority has decided to provide a final opportunity for re-medical examination to affected candidates, this time considering medical standards A2 to C1.

Important Instructions:

- Photocopies (in two sets) of all relevant documents, duly self-attested by the candidate with the date of attestation.
- Ten (10) copies of photographs(size 2.5 cm x 3.5 cm.) (same as submitted during the previous medical examination).
- Bring all original certificates along with the new annexure of the caste certificate for verification.
- **If any above-mentioned pending candidate fails to appear or walk out, for any reason whatsoever on above-mentioned date or fails to bring any required documents, his/her candidature will remain cancelled and no further chance will be provided. Candidate will be fully responsible for cancellation of his/her candidature for the post in level-1 against CEN RRC 01/2019.**
- It is hereby clarified that any candidate who is currently employed in any Government service, must produce a **No Objection Certificate (NOC)** from his current employer at the time of re-check of document.
- It is clarified that **being called for re-check of document and re-medical examination does not confer any right to appointment** against the notified posts.
- All candidates appearing for document re-verification are required to bring the following documents **in original**:“CBT Admit Card, PET Admit Card&DV Admit Card”. In case any of the mentioned admit cards have been **lost or misplaced**, the candidate must produce a valid **FIR or General Diary (GD) entry** from the concerned police station as proof of loss with an application. Failure to provide the original admit cards or FIR/GD in case of loss may result in disqualification from the selection process.

Candidates are advised to ensure compliance with the above instructions to avoid any inconvenience during the verification process.

Candidates are responsible for arranging their own accommodation for 3-4 days, if necessary, and all related expenses must be borne by them. No any kind of travel allowance or daily allowance (TA/DA) will be provided.
